PROPOSAL: The applicant proposes amendments to Chapter 18.67 of Deschutes County Code, to allow a recreational vehicle (RV) park as a conditional use in the Tumalo Commercial District (TUC). The applicant also proposes development and siting standards for new RV parks in the TUC Zone.
