SUBJECT: Treasury Report for October 2025

Following is the unaudited monthly treasury report for fiscal year to date (YTD) as of October 31, 2025.

Treasury and Investments

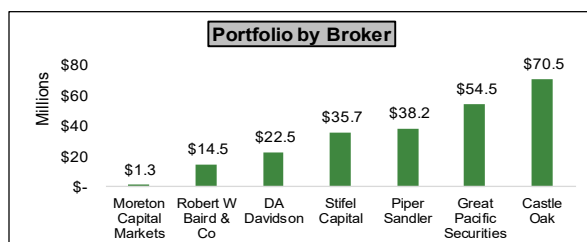
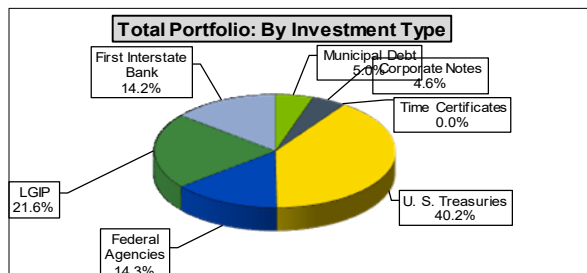
- The portfolio balance at the end of October was \$369.4 million, an increase of \$66.1 million from September and an increase of \$89.6 million from last year (October 2024).
- Net investment income for October was \$1,011.3K, approximately \$5.7k higher than last month and \$198.5k greater than October 2024. YTD earnings of \$4,070.5K are \$1,622.9K more than the YTD earnings last year.
- All portfolio category balances are within policy limits.
- The LGIP interest rate reduced to 4.50% during the month of October. The FIB rate was 3.95%. Benchmark returns for 24-month treasuries were down 5 basis points and 36-month treasuries were down 5 basis points from the prior month.
- The average portfolio yield dipped slightly to 4.18%, which was down 1 bps from last month's average %.
- The portfolio weighted average time to maturity was .83 years.

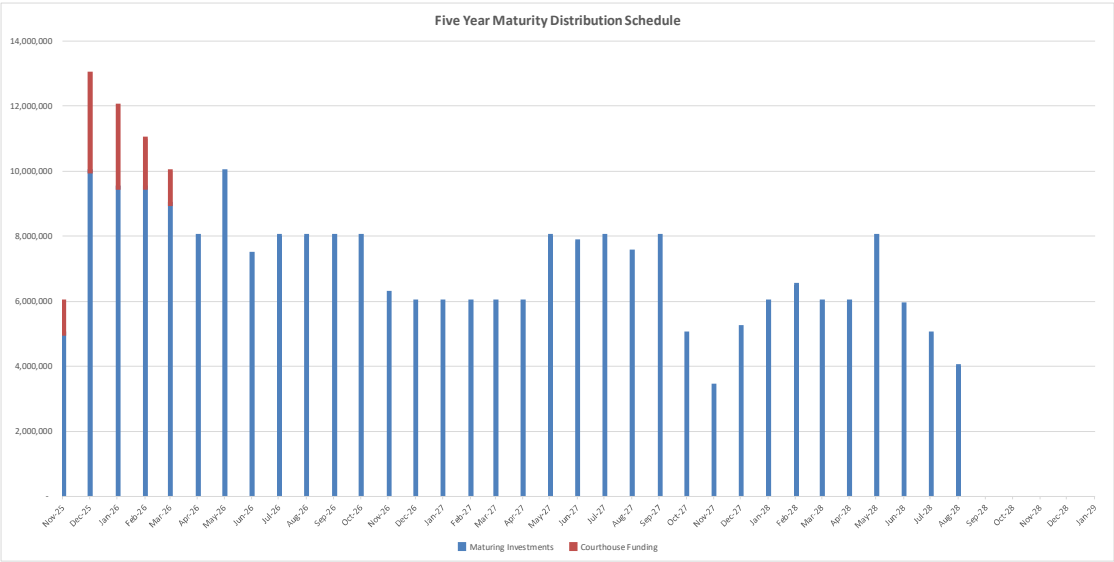
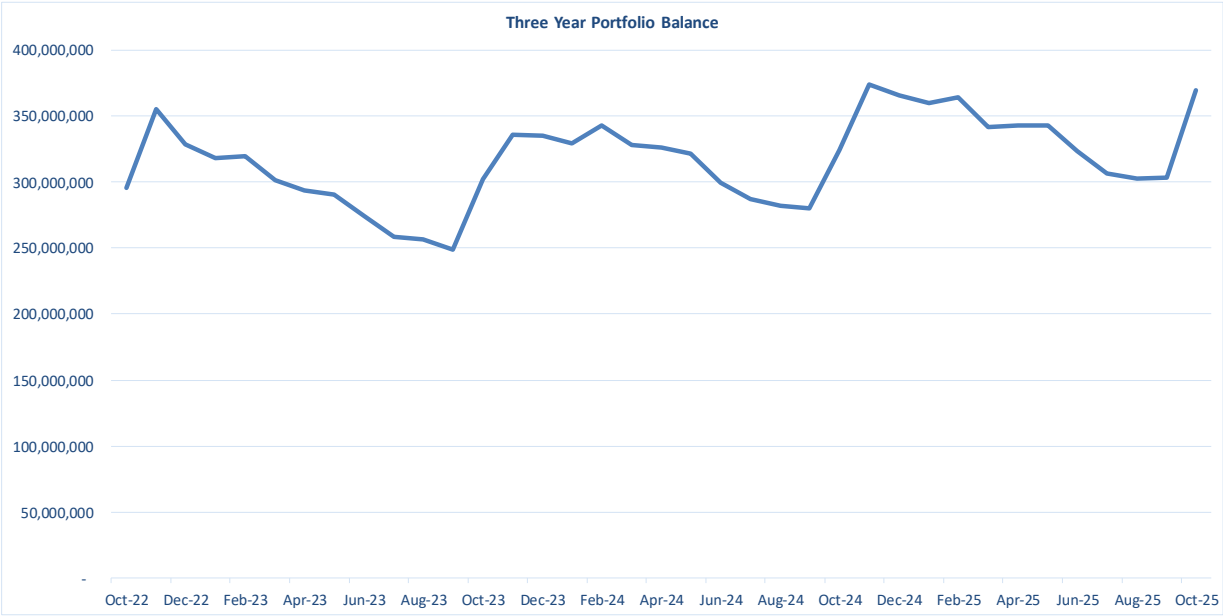
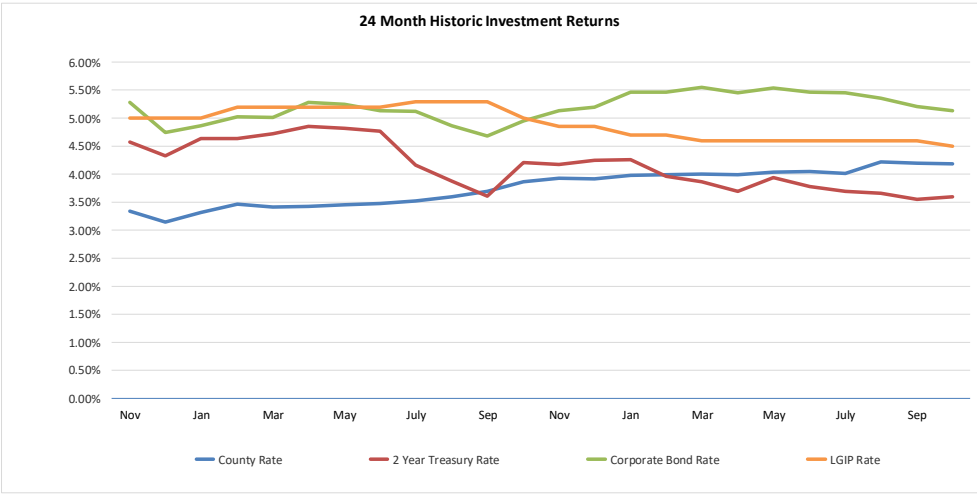
