

## **VSQG Disposal Pricing**

Use the list of common wastes below to estimate your disposal fees. Rates are calculated by container size with the exception of antifreeze, motor oil, and flammable liquids for consolidation, which will be calculated by volume regardless of container size. The information below is intended to be a guide and actual fees will be calculated when you drop off your waste.

## **PaintCare Accepted Items**

PaintCare is a nonprofit organization that manages leftover paint by operating a stewardship program in certain states including Oregon. A small fee is added to the price of new paint sold allowing PaintCare to take unwanted or unused paint for free. The paint collected is then recycled into new paint or reused in another manner. Below is a list of acceptable paint that can be dropped off free of charge as well as a list of items that are not included. All containers must be 5 gallons or less and have the original manufacturers label to qualify.

### Accepted

- Interior and exterior architectural paints: latex, acrylic, water-based, alkyd, oil-based, enamel (including textured coatings)
- Deck coatings, floor paints (including elastomeric)
- Primers, sealers, undercoaters
- Stains
- Shellacs, lacquers, varnishes, urethanes (single component)
- Waterproofing concrete/masonry/wood sealers and repellents (not tar or bitumenbased)
- Metal coatings, rust preventatives
- Field and lawn paints

### **Not Accepted**

- Paint thinners, mineral spirits, solvents
- Aerosol coatings
- Auto and marine paints
- Art and craft paints
- Caulking compounds, epoxies, glues, adhesives
- Paint additives, colorants, tints, resins
- Wood preservatives (containing pesticides)
- Roof patch and repair
- Asphalt, tar and bitumen-based products
- 2-component coatings
- Deck cleaners
- Traffic and road marking paints
- Industrial Maintenance (IM) coatings
- Original Equipment Manufacturer (OEM) (shop application) paints and finishes
